

Daycare Agreement

1. OWNER REPRESENTATIONS

Owner represents that said pet(s) is in all respects healthy and has received all required and customary immunizations, is receiving a form of flea control approved by Here, Doggy! and does not suffer from any illness, disability or condition which could affect said pets' or other pets' safety at Here, Doggy! Daycare.

2. ACKNOWLEDGEMENT OF RISKS AND RESPONSIBILITIES

I, the undersigned, recognize that there is an inherent risk of injury or illness in any environment associated with cage-less dog daycare. I also recognize that such risks include, without limitation, injuries or illness from fights, rough play, contagious diseases and/or unwanted pregnancies. Knowing these inherent risks and dangers, I warrant that I, or the owner for who I am assigning as an adult guardian, will abide by all safety rules and instructions. I agree by this contract to assume full responsibility and hold Here, Doggy!, LLC, its agents or employees harmless for said pet's injury, death or damage as the result of any incident including my or other's negligence, except to the extent that the damage or injury may be due to willful misconduct of Here, Doggy!, LLC. I further agree to hold Here, Doggy!, LLC harmless and indemnify it against all damage costs, fees and business losses resulting from any claim I make or cause to be made against Here, Doggy!, LLC for which it, its agents or employees are not ultimately held to be legally responsible.

3. OWNER LIABILITY

I, the undersigned, expressly agree to be held responsible for any damage or cost incurred by my pet(s), including but not limited to destruction of furniture, gates, walls, as well as any injury inflicted upon another dog (or my dog) as a result of a fight or rough play.

4. LIMITATIONS ON CAGE-LESS DOG DAYCARE

I, the undersigned, understand that if my dog displays repeated aggressive behavior, that for the safety and health of my dog(s) and others, my dog will be confined to a kennel for the remainder of that visit with no offset or deduction in price. I understand that if my dog continues to display undesirable behaviors, my dog(s) may be asked to leave Here, Doggy!, LLC permanently.

5. DOG ABANDONMENT

I, the undersigned, understand that Here, Doggy!, LLC Is not a dog shelter. If I need to leave my dog longer than expected, I will contact Here, Doggy!, LLC with my expected return. I understand that if I abandon my dog at Here, Doggy!, LLC for more than one week (7 days), Here, Doggy!, LLC will, by default, become the legal owner and guardian of the dog. I understand that I am responsible for any boarding charges incurred during



this process. Here, Doggy!, LLC will, in their sole discretion, determine whether to try to re-home and adopt the dog or will relinquish the dog to an unrelated shelter of their choice. I FULLY UNDERSTAND AND AGREE THAT IF I ABANDON MY DOG AT HERE, DOGGY!, LLC, I MAY BE UNABLE TO RETRIEVE POSSESSION OF MY DOG AND WILL HAVE NO RECOURSE AGAINST HERE, DOGGY!, LLC.

6. LEASH POLICY

I, the undersigned, understand that I am responsible for my dog's behavior in the lobby and outside of Here, Doggy!, LLC. If my dog is hurt, hurts another dog or human, or escapes from my control, it is solely my responsibility. All dogs are required to be on leash while in the lobby, in the parking lot, and immediately outside of the Here, Doggy!, LLC premises. If I choose to have my dog off leash, I am liable for any injury or other damage (including runaways) that may occur.

7. SOCIAL MEDIA

I, the undersigned, understand that my dog's image may be posted on Here, Doggy!, LLC's website or social media channels, including, but not limited to Instagram and Facebook. If I do not want my dog's image posted online, I will provide a written request to Here, Doggy!, LLC.

I REPRESENT THAT I HAVE MADE FULL DISCLOSURE AND HAVE READ, UNDERSTAND, ACCEPT THE TERMS AND CONDITIONS STATED IN THIS AGREEMENT, AND ACKNOWLEDGE THAT THIS AGREEMENT SHALL BE EFFECTIVE AND BINDING UPON PARTIES.
